Money from purchasing the covenant is often reinvested in infrastructure at the property or used to pay down mortgages. Maine Revenue Services	Working Waterfront Tax Law	The Current Use Valuation of Certain Working Waterfront Land law was enacted to encourage the preservation of Maine's working waterfront and to prevent the conversion of this land as the result of economic pressures caused by high property taxes. The program is intended to support commercial fishing activities.	Individuals	Statewide	The law requires an assessor to calculate the value of working waterfront property based on its use as working waterfront land, rather than the market value of the property at its highest and best use.
